Account Delinquency Policy	
A. Due to HCA's dependency on revenue from accounts to pay operational costs, all Accounts must remain current using one of the four payment options mentioned above. Accounts include but are not limited to, tuition, resource fees, after care and Extended Care fees.	
B. All payments submitted for collection, which are returned from a banking institution as not payable, will be assessed a bank service fee, and will be considered Past Due and subject to the terms of this Delinquency Policy.	
C. Any account not current by the day after the due date is considered "Past Due."	
<b>First Month of Past Due Balance</b>	
1st Month Late fee \$25 and an email or letter notice to responsible party(ies).	
<b>Second Month of Past Due Balance</b>	
2 <sup>nd</sup> Month Late Fee \$25 and email or letter notice to responsible party(ies).	
<b>Third Month of Past Due Balance</b>	
3 <sup>rd</sup> Month Late Fee \$25 and student is suspended on the day after payment is due for that month.	
o The student may not participate in any school activities until the account is brought current.	
o The suspension will be canceled when the account is brought current.
