ACCOUNT DELINQUENCY POLICY

A. Due to HCA's dependency on revenue from accounts to pay operational costs, all Accounts must remain current using one of the four payment options mentioned above. Accounts include but are not limited to, tuition, resource fees, after care and Extended Care fees.

B. All payments submitted for collection, which are returned from a banking institution as not payable, will be assessed a bank service fee, and will be considered Past Due and subject to the terms of this Delinquency Policy.

C. Any account not current by the day after the due date is considered "Past Due."

First Month of Past Due Balance

1st Month Late fee \$25 and an email or letter notice to responsible party(ies).

Second Month of Past Due Balance

2nd Month Late Fee \$25 and email or letter notice to responsible party(ies).

Third Month of Past Due Balance

3rd Month Late Fee \$25 and student is suspended on the day after payment is due for that month.

- o The student may not participate in any school activities until the account is brought current.
- o The suspension will be canceled when the account is brought current.

2025-26 Harvest Christian Academy Tuition Discount Policy

Harvest Christian Academy (HCA) desires to partner with families to make Christian education accessible while maintaining its commitment to top-class professional educators, academic rigor with Biblical integration, and programmatic advancement across all departments. Consequently, HCA offers the following tuition discounts applied in this order.

Multi Student Discounts are available for kindergarten through grade 12's academic programs beginning with the second student.

- Student two receives a \$500 credit
- Student three receives a \$1000 credit
- Student four (or more) receive a \$2000 credit

Tuition Assistance is available to any family who qualifies based on an application to and recommendation from FACTS, a third-party tuition assistance firm. While every enrolling family may apply for tuition assistance, awards, if any, are based upon various factors, including income level, overall assets, overall expenses, and number of children. Please note student qualification is for kindergarten through grade 12.

Bridge Discounts to Lower School are available for kindergarten students who attended HCA's Early Learning program (but are not applied with the Tuition Assistance program*).

Kindergarten a \$500 credit for a previous prekindergarten enrollment

ONE DISCOUNT MAY BE USED WHERE TUITION ASSISTANCE IS NOT APPLIED Pay in Full Discounts are available for all families paying tuition in full (lump sum) for the academic year on or before August 2. The up-front payment discount is 2% of total tuition and is applied after any other qualifying discounts are applied.

Pastoral Discounts are available for full-time church staff employed in any Gospel-partnering Christian Church at 50% of overall HCA tuition.

Documentation of employment is required.

Full-time employment is defined as serving in a role of employment for at least 32 hours per week.

Ministry Staff Discounts are available for full-time staff employed in any Gospel-partnering Christian Ministry.

Ministry staff discounts are 25% of overall HCA tuition.

Documentation of employment is required.

Full-time employment is defined as serving in a role of employment for at least 32 hours per week.

Legacy Discounts are available for any parent of a student is a Harvest Christian Academy alum/alumna. The discount is 25% of overall HCA tuition.

ROAR Referral Discounts are applied in the second semester and are available for any family who refers prospective students who enroll. (Tuition credit may roll to the next school year and be applied first.*) Please see the details for this program at harvestchristianacademy.org/roar.

- PS/PK referrals are worth \$250
- GR K-12 referrals are worth \$1500

Stacking discounts*: Stacking or combining any of the above discounts is not available. If a family qualifies for multiple discounts, the single greatest discount amount is automatically applied, unless otherwise requested by the family. However, the up-front (2.0%) discount and/or sibling discount may be combined with any other single discount.

Waiving discounts: Families may choose to waive any of the above discounts they qualify for (excluding the up-front discount) for a tax deduction. The waived discount(s) will be considered a donation to Harvest Christian Academy.
